CONDITIONS OF USE

- 1) This form is valid for five years from the date of signing. The consent will automatically expire after this time.
- 2) We will not re-use any images after this time.
- 3) North East Wales Wildlife will not include details or full names (which means first name **and** surname) of any individual in an image on video, on our website, or in printed publications. However, visiting photographers from the local press may wish to use full names. If this occurs, NEWW will request that the photographer seeks the permission of the teacher/parent/guardian/individual (as appropriate).
- 4) We will not include personal email or postal addresses, or telephone or fax numbers on video, on our website or in printed publications without good reason.
- 5) If we use images of individual children, we will not use the name of that child in the accompanying text or photo caption. However, visiting photographers from the local press may wish to use full names. If this occurs, NEWW will request that the photographer seeks the permission of the teacher/parent/guardian/individual (as appropriate).
- 6) We may use group images with very general labels, such as “the volunteer group clearing a pond”. This may include the name of the voluntary organisation e.g. ‘Volunteers from (name of voluntary organisation) planting trees’.
- 7) We will only use images of children who are suitably dressed, to reduce the risk of such images being used inappropriately.
